



## 2026 State Line Heritage Days Flea Market Vendor Registration

**Dates:** The 2026 festival will run Wednesday, July 29<sup>th</sup> through August 1<sup>st</sup>, 2026

**Fee:** Flea market space is \$25 for a 10' x 10' or \$40 for a 10' x 20'.

There is an additional \$10 charge to add electricity if available.

All vendor applications and fees must be received by the committee on or before July 22, 2026, to guarantee space.

**Setup:** Vendors must be set up by 5:00 PM on Wednesday July 29, 2026.

Please have a copy of your application with you to expedite check-in.

**Times:** All vendors must be in place and open for operations from 10:00 am until 7:00 pm each festival day.

You may stay open after 7:00 pm but it is not mandatory.

**Misc.** For safety reasons, flea market booths are prohibited from leaving until entertainment is over and the crowd has dispersed on the last day of the festival.

Any vehicles next to your space must remain stationary until after 7:00 pm each day of the festival .

All vendors must comply with the Health Dept & State Fire Marshal standards.

Fire extinguishers are required for all flea market vendors.

Saturday will be advertised as a "blow-out" day. Participation is optional.

Bring 3 paid vendors and get \$25 off your space next year.

The following items are not allowed to be sold; firearms, explosives, expired food, prescription medications, counterfeit or stolen property, pirated media, live animals, chemicals, etc.
